SECTION 4: First-Aid Measures

4.1. Description of first aid measures

The symptoms resulting from intoxication can appear after exposure, therefore, in case of doubt, seek medical attention for direct exposure to the chemical product or persistent discomfort, showing the MSDS of this product.

- By consumption: Request medical assistance immediately, showing the MSDS of this product. Do not induce vomiting, but if it does happen keep the head up to avoid inhalation. In the case of loss of consciousness do not administrate anything orally unless supervised by a doctor. Rinse out the mouth and throat, as they may have been affected during ingestion. Keep the person affected at rest.

SECTION 5: Fire-Fighting Measures

5.1. Extinguishing media

Product is non-flammable under normal conditions of storage, manipulation and use. In the case of inflammation as a result of improper manipulation, storage or use preferably use polyvalent powder extinguishers (ABC powder), in accordance with the Regulation on fire protection systems. IT IS NOT RECOMMENDED to use tap water as an extinguishing agent.

5.2. Special hazards arising from the substance or mixture

As a result of combustion or thermal decomposition reactive subproducts are created that can become highly toxic and, consequently, can present a serious health risk.

5.3. Advice for fire-fighters

Depending on the magnitude of the fire it may be necessary to use full protective clothing and individual respiratory equipment. Minimum emergency facilities and equipment should be available (fire blankets, portable first aid kit,...) in accordance with Directive 89/654/EC.
