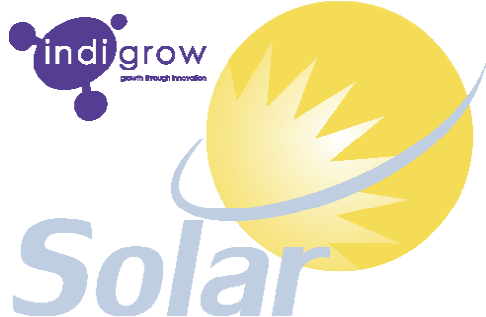

## SECTION 4: First-Aid Measures

### 4.1. Description of first aid measures

## SECTION 5: Fire-Fighting Measures

### 5.1. Extinguishing media
